# Introduction

The Global Talent Visa provides opportunities for highly skilled individuals in various domains, including science, engineering, medicine, humanities, digital technology, and arts and culture (such as film and television, fashion design, and architecture), who desire to work in the United Kingdom. 'Talent' applicants are already distinguished leaders in their respective fields, while 'promise' applicants have the

potential to become future leaders in their field.

The Global Talent category does not have a limit on the number of applicants, does not necessitate a job offer, and offers a pathway to settlement in the UK. Additionally, eligible individuals can apply for their dependent partner and children under the age of 18 to accompany them under this visa route.





# The criteria for obtaining the Global Talent Visa

To be eligible for a Global Talent visa, you must meet the following criteria, as assessed by UK Visas and Immigration:

**1. Age:** You must be 18 years of age or older.

**2. Endorsement:** You must possess an endorsement letter from an endorsing body approved by the Home Office, or have received a prestigious prize listed in Appendix Global Talent: Prestigious Prizes.

**3. General grounds for refusal:** Your application should not fall under the general grounds for refusal.

**4. TB certificate:** If applicable, you must provide a valid TB (tuberculosis) certificate.

# Application for Global Talent Endorsement

To apply for a Global Talent visa, most applicants are required to obtain an endorsement from a suitable endorsing body, which serves as evidence of their exceptional talent or promise. The endorsement can be obtained in various fields, including science, engineering, medicine, social science and humanities, digital technology, and arts and culture (such as film and television, fashion design, and architecture). Each endorsing body has its own specific criteria for granting a Global Talent endorsement. However, in all cases, you will need to demonstrate a significant body of work and obtain support from experts in your field.

For detailed information on the endorsement requirements in each field, please refer to the following Details.



## Global Talent Visa for Arts and Culture

The Global Talent visa is available for individuals in the arts and culture fields who are talented and have the potential to be leaders. Arts Council England determines the eligibility for endorsement in various areas, including

combined arts, dance, literature, music, theatre, and visual arts. There is no limit on the number of applicants who can be endorsed in the Arts and Culture sub-category of the Global Talent route.



## Global Talent Visa Arts and Culture Requirements

To be eligible for a Global Talent visa in the Arts and Culture field, you must meet the following criteria:

**1. Age:** You must be 18 years old or above.

**2. Endorsement:** You need to obtain an endorsement letter from Arts Council England or have been awarded a prize listed in Appendix Global Talent: Prestigious Prizes. This endorsement serves as evidence of your exceptional talent or promise in the arts and culture field.

**3. General Grounds for Refusal:** Your application should not fall under the

general grounds for refusal, which include factors such as criminal convictions, immigration violations, or posing a threat to national security.

**4. Tuberculosis (TB) Certificate:** If required, you must provide a valid TB certificate as part of your visa application.

It's important to note that the specific requirements may vary depending on your individual circumstances. If you have any doubts or questions regarding your eligibility, it is advisable to seek expert advice from an immigration lawyer.

## Requirements for Endorsement by Arts Council England

To be eligible for an endorsement by Arts Council England in the Arts and Culture field, you must meet the following requirements:

**1.** Be professionally engaged in producing outstanding work that has been internationally performed, presented, distributed, or exhibited.

**2.** Exceptional Promise applicants should be at an early stage in their career, while Exceptional Talent applicants should be further along in their career.

**3.** Have a regular engagement as a professional practitioner in your field within the last five years.

**4.** Demonstrate a substantial track record in at least two countries for Exceptional Talent applicants, or a developing track record in one or more countries for Exceptional Promise applicants.

Make sure to carefully review the specific requirements and guidelines provided by Arts Council England for a comprehensive understanding of the endorsement process.



## Evidences Required by Arts Council England

To apply for an Arts and Culture endorsement from Arts Council England, you will need:

- Three letters of recommendation, including two from well-established arts and culture organizations you have worked with (at least one based in the UK), and one from another organization or an individual with recognized expertise in your field.
- A CV to provide information about your career stage in the arts and culture field.

## Evidences Required by Arts Council England

To demonstrate exceptional talent in Arts and Culture, you must provide evidence of at least two of the following:

### 1. Media Recognition:

Show significant media recognition for your work in at least two countries, including your country of residence. This can be as an individual, a member of a group, or a contributor to internationally recognized orchestras, dance troupes, etc.

### 2. Awards:

Present evidence of winning or making a



significant contribution to winning at least one international award for excellence.

### 3. Performances, Publications, or Exhibitions:

Provide proof of internationally significant appearances, performances, publications, or exhibitions in your field in at least two countries, including your country of residence. Alternatively, show evidence of extensive international distribution and audiences for your work as an individual, group member, or contributor.

## Exceptional Promise Applicants in the Field of Arts and Culture

To demonstrate exceptional promise in Arts and Culture, you need to provide evidence of at least two of the following:

### 1. Media Recognition:

Show evidence of recent media recognition for your work in at least one country, including your country of residence. This can be in the form of at least two examples highlighting your individual work, group membership, or contributions.

### 2. Awards:

Present evidence of winning, significantly contributing to winning, being nominated, or shortlisted for at least one international award for excellence.

### 3. Performances, Publications, or Exhibitions:

Provide evidence of recognized appearance performances, publications, or exhibitions in your field in at least one country, including your country of residence. Alternatively, demonstrate international distribution and audiences for your work as an individual, group member, or contributor.

## Does Arts Council England Require Referees & CV?

Arts Council England requires three letters of recommendation for your application. One letter must come from a well-established UK-based organization or institution recognized for its expertise in your field. The second letter should also be from a reputable organization or institution, which can be based in the UK or overseas. The third letter can be from either another recognized organization or an individual with internationally recognized expertise in your field. These letters should be written by senior members who are familiar with your work and can provide details about your achievements and potential as a leader in your field.

Additionally, you are required to submit a CV to help Arts Council England understand your current stage in your arts and culture career.





## Endorsement Application Decision Times by Arts Council

---

The decision-making process for an endorsement application by Arts Council England typically takes between six and eight weeks. After submitting your application, the Home

Office will confirm that it has been sent for consideration, and a decision is expected within 25 working days.

## Global Talent Visa Application Following Endorsement

---

Once you have received your endorsement from Arts Council England, you have three months to submit your application for the Global Talent visa in the UK. If you are already in the UK, you can apply to switch into the Global Talent route as long as you don't hold or were not last granted permission to stay under specific

categories such as Visitor, Short-term Student, and Parent of a Child Student, Seasonal Worker, or Domestic Worker. If you are currently in any of the above categories, you will need to leave the UK and apply for the Global Talent visa from your home country. However, you can make the application from anywhere in the world, not necessarily



your home country.

Apart from meeting the endorsement requirement, the Home Office will also assess your character and immigration history to ensure you don't fall under the general grounds for refusal. There is no requirement for maintenance funds or English language proficiency

in the Global Talent visa category.

You can request leave for the desired period, up to a maximum of five years. The requested duration doesn't impact the application itself but will affect the amount you need to pay for the Immigration Health Surcharge.

## Global Talent Visa for Film and Television



Talented individuals in the film and television industry have the opportunity to apply for the Global Talent visa route to work in the UK. Their leadership status in their respective fields will be determined by the Producers' Alliance for Film and Television (PACT) on behalf of Arts Council England.

PACT, representing Arts Council England, has the authority to endorse applications in the film, television, animation, post-production, and visual effects industries.

There is no limit to the number of applicants that can be endorsed in the Film and Television sub-category of the Global Talent route.

However, it is important for individuals working in these industries to demonstrate "exceptional talent" in their applications. PACT does not endorse applications based on "exceptional promise."

### Requirements by PACT

To be eligible for a Global Talent visa in the Film and Television field, you must meet the following criteria as required by UK Visas and Immigration:

- 1. Age:** You must be 18 years of age or older.
- 2. Endorsement:** You need to obtain an endorsement letter from PACT (Producers'





Alliance for Film and Television) or have been granted a qualifying prestigious prize listed in Appendix Global Talent: Prestigious Prizes.

**3. General grounds for refusal:** Your application should not fall under any of the general grounds for refusal.

**4. TB certificate:** If required, you must provide a valid TB (tuberculosis) certificate. Please note that the specific requirements may vary based on your individual circumstances. If you need detailed guidance, it is advisable to consult an immigration lawyer for expert advice.

## **Requirements for Endorsement by PACT**

In order to be endorsed by PACT (Producers' Alliance for Film and Television) within the film, television, animation, post-production, and visual effects industries, the criteria primarily revolve around recognition through awards. You will need to fulfill at least one of the following criteria:

**1. Award Achievement:** You have won an Academy Award, a British Academy of Film and Television Arts (BAFTA) award (Film, Television, Television Crafts, Cymru, Scotland, Games awards only), a Golden Globe, or an Emmy Award.

**2. Nomination or Contribution:** Within the last 10 years, you have been nominated for, or made a significant contribution to winning, or being nominated for a Academy Award, a BAFTA award, a Golden Globe, or an Emmy Award.

**3. Multiple Nominations:** In the last 15 years, you have achieved a minimum of 2 nominations for an Academy Award, a BAFTA award, a Golden Globe, or an Emmy Award.

**4. Notable Industry Recognition:** You have notable industry recognition through a combination of international distribution sales, media recognition, and specific awards from PACT's Notable Industry List.

It is important to thoroughly review the nearly 200 awards on the PACT Notable Industry List to determine if you meet the criteria. Additionally, when relying on these awards, you must also demonstrate international distribution sales and media recognition, unlike the previous options where having the awards alone is sufficient.

## Evidence Required for Endorsement

To obtain an endorsement by PACT (Producers' Alliance for Film and Television) in the Film and Television industry, your application should include three letters of recommendation.

**1.** The first letter should be from a well established UK based organization, institution, or company recognized for its expertise in the film and television industry, both nationally and internationally.

**2.** The second letter should also come from a reputable organization, institution, or company with expertise in the film and television industry. This organization can be based in the UK or overseas.

**3.** The third letter can either be from another well established organization, institution, or company in the film and television industry (based in the UK or overseas) or from an esteemed individual internationally recognized for their expertise in the field.

These letters should be provided by senior members of the respective organizations who are familiar with your work and able to provide insights into your achievements. They should outline your accomplishments in your specialized area and present how, in their opinion, you have demonstrated leadership in your field.





## Application Decision Times & Following Endorsement

---

PACT usually take between six and eight weeks in total from submission to make a decision on endorsement. Once you receive your endorsement from PACT, you have three months to apply for the Global Talent visa in the UK. If you are already in the UK, you can switch to the Global Talent route unless you currently hold certain types of visas. In that case, you would need to leave the UK and apply for the visa from your home country.

In addition to the endorsement, the Home Office will evaluate your character and immigration history to ensure you meet the general grounds for approval. There are no specific requirements for maintenance or English language proficiency in the

Global Talent visa category.

The duration of the visa can be requested for up to five years in full-year periods, and it does not affect the application process but does affect the Immigration Health Surcharge fee. Since you have been endorsed as "exceptionally talented," you may be eligible to apply for settlement after three years in the UK. However, there are residency requirements, so if you anticipate frequent travel, you might consider applying for a longer period than the required three years.

## Global Talent Visa for Architecture

The Global Talent visa route welcomes skilled and aspiring individuals in the architecture field who desire to work in the UK. Applicants should demonstrate leadership qualities in their field or possess the potential to become leaders. This determination is made by The Royal Institute of British Architects

(RIBA) on behalf of Arts Council England. In the Architecture sub-category of the Global Talent route, there is no limit to the number of applicants that can be endorsed, providing ample opportunities for talented individuals in this field.



### Requirements by the Royal Institute of British Architects (RIBA)

To be eligible for a Global Talent visa in the field of Architecture, you must meet the following requirements as determined by UK Visas and Immigration:

- **Age:** You must be 18 years of age or older.
- **Endorsement Letter:** You must possess an endorsement letter issued by The Royal Institute of British Architects (RIBA) or have received a qualifying prestigious prize listed in Appendix Global Talent: Prestigious Prizes.
- **General Grounds for Refusal:** Your application should not fall under the general grounds for refusal.
- **TB Certificate:** If required, you must provide a valid certificate demonstrating that you have been screened for tuberculosis.



## Exceptional Talent Applicants in the Field of Architecture

in the last five years that are considered internationally significant in your field. These examples should be recognized and respected within the architectural community and can be from at least one country, including your country of residence.

By fulfilling these requirements, you can demonstrate your exceptional promise in the field of Architecture for your Global Talent visa application.

### Does RIBA Require Referees for Architecture Endorsements?

Yes, **RIBA (The Royal Institute of British Architects)** requires three letters of recommendation to support your application for an endorsement in the field of Architecture. The letters should meet the following requirements:

**1. First Letter:** The first letter must come from a UK-based organization that is widely acknowledged as possessing expertise in your specialist field of Architecture. This organization should be well-established nationally and/or internationally.

**2. Second Letter:** The second letter should also come from an organization that is well-established nationally and/or internationally and widely acknowledged as possessing expertise in your specialist field. This organization can be based in the UK or overseas.

**3. Third Letter:** The third letter can either be from another organization, either UK or overseas based, that is well established and widely acknowledged in your specialist field, or it can be from an eminent individual with internationally recognized expertise in your field.

All three letters should be written by senior members of the respective organizations or individuals who are familiar with your work and can provide an assessment of your achievements. They should specifically highlight your achievements in your specialist field and explain how, in their opinion, you have demonstrated the potential to become a leader in the field of Architecture.

These letters of recommendation play a crucial role in supporting your application for endorsement by RIBA.



## Application Decision Times & Following Endorsement

---

RIBA usually takes 4 weeks in total from submission to make a decision on an architecture endorsement. Once you have received your endorsement from the Royal Institute of British Architects (RIBA), you will have a three-month period starting from the date of the endorsement letter to submit your application for entry or permission to remain in the UK under the Global Talent category.

If you are already in the UK and wish to switch to the Global Talent route, you can apply from within the country. However, this applies only if you do not currently hold or were not last granted permission to stay as a Visitor, Short-term Student, and Parent of a Child Student, Seasonal Worker, and Domestic worker in a private household, or under any other category outside the Immigration Rules. If you fall under any of these categories, you will be required to leave the UK and apply for a Global Talent visa from your home country.

If you are outside the UK and do not hold any valid leave, you should ensure that you are abroad when you submit your Global Talent visa application. The application can be made from any location worldwide, so you are not obligated to travel to your home country specifically to make the application.

In addition to the endorsement, the Home Office will assess your character and immigration history to ensure that you do not meet the general grounds for refusal.

It is important to note that there are no maintenance or English language requirements in the Global Talent visa category.

The duration of leave granted under the Global Talent visa category will be based on the period you request, up to a maximum of five years. The requested duration does not impact the application itself but will affect the amount you need to pay for the Immigration Health Surcharge.

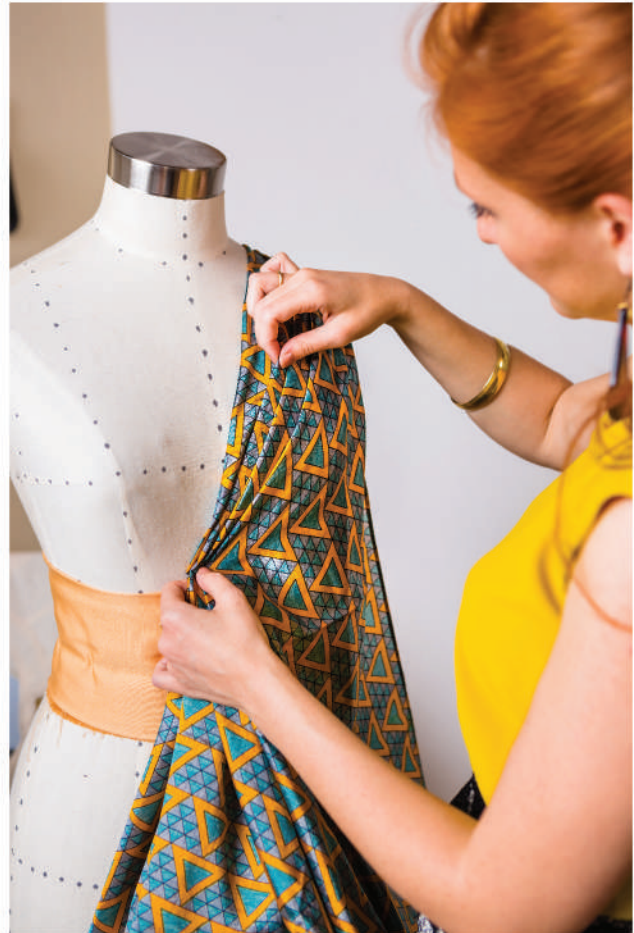
## Global Talent Visa for Fashion

---

The Global Talent visa route welcomes talented and promising individuals in the fashion design industry who aspire to work in the UK. To qualify, applicants must demonstrate leadership in their field or possess the potential to become leaders, as determined by the British Fashion Council (BFC) on behalf of Arts Council England.

The endorsement by the British Fashion Council applies to individuals holding a prominent design role within the fashion business. They can endorse applications from such individuals operating in the fashion design industry.

In the fashion industry sub-category of the Global Talent route, there is no limitation on the number of applicants that can receive endorsement.



### Global Talent Visa Fashion Design Requirements

---

To be eligible for a Global Talent visa in the field of Fashion Design, you must meet the following criteria as required by UK Visas and Immigration:

- **Age:** : You must be 18 years of age or older.
- **Endorsement Letter:** You need to possess an endorsement letter issued by the British Fashion Council (BFC). Alternatively, you may have been awarded a prize listed in Appendix Global Talent: Prestigious Prizes.

- **General Grounds for Refusal:** Your application should not fall under the general grounds for refusal specified by UK Visas and Immigration.

- **TB Certificate:** If required, you must provide a valid tuberculosis (TB)

certificate.

It's important to note that the specific requirements may vary depending on your individual circumstances. For personalized and expert advice, it is advisable to consult with an immigration lawyer.

## Requirements for Endorsement by British Fashion council (BFC)

To be endorsed by the British Fashion Council in fashion design, you must hold a prominent design position in the fashion industry and exhibit consistent professional involvement in the field over the past five years. Additionally, you need to showcase exceptional work that has achieved international sales or exhibitions,

including catwalk shows. If you are applying under the Exceptional Talent criteria, you must have an established presence in multiple countries. For the Exceptional Promise criteria, it is essential to demonstrate a growing presence in one or more countries, along with recognition from prominent industry figures.

## Evidence Required for Endorsement by British Fashion council (BFC)

To support your Fashion Design endorsement application with the British Fashion Council (BFC), you will need three letters of recommendation.

These letters should come from reputable organizations in the fashion industry that have recognized expertise at a national or international level.

If you are aiming to demonstrate exceptional talent in Fashion Design, at least one of the recommendation letters must be from a UK-based organization.





## Exceptional Talent Applicants in the Field of Fashion Design

---

For applicants seeking to demonstrate exceptional talent in the fashion design industry, it is necessary to provide evidence of at least two of the following:

**1. Awards:** Proof of winning, significantly contributing to winning, being nominated for, or significantly contributing to being shortlisted for an international award for excellence

**2. Media Recognition:** Documentation from at least two countries, including your country of residence, showcasing a minimum of two instances of significant

media recognition for your individual work.

**3. Shows, presentations or Exhibitions:**

Evidence of participating in catwalk shows, presentations, or exhibitions that are considered internationally significant in the fashion design industry.

**4. Distribution and sales:** Documentation demonstrating extensive distribution and sales of your collections through internationally renowned retailers, your own retail outlet, or your own e-commerce platform.

## Exceptional Talent Applicants in the Field of Fashion Design

**1. Media Recognition:** At least two recent examples of media recognition for your individual work from either the UK or international sources.

schemes, Fashion East support scheme, The Sarabande Foundation, The Centre of Fashion Enterprise, or an international counterpart of the British Fashion Council.

**3. Orders:** Evidence of at least one order placed by a luxury retailer or boutique.

**4. Industry recognition:** Documentation indicating recognition by leading industry players for an exceptional graduating collection.

## Does the BFC Require Referees for a Fashion Design Endorsement?

---

Yes, the British Fashion Council (BFC) requires applicants to provide three letters of recommendation as part of the Fashion Design endorsement application.

These letters of recommendation must be from senior members of established organizations with a national or international reputation and recognized expertise in the fashion industry.

If you are applying under the Exceptional Talent criteria, it is mandatory for at least one of the letters to come from a well-established UK organization. This organization should have a national or international

presence, work with numerous international designers and industry experts each year, and be widely acknowledged for its expertise in the field of fashion.

The letters should be written by senior members of the organization who are familiar with your work and can provide detailed insights into your achievements. ## Application Decision Times & Following Endorsement for Fashion Design

The BFC usually takes about 4 weeks in total from submission to make a decision on a fashion design endorsement. Once you have received your endorsement from the British Fashion Council (BFC), you will have a three-month window from the date of the endorsement letter to submit your application for entry or remaining in the UK under the Global Talent category.

Leave will be granted for the duration you request, in full-year periods, for up to a maximum of five years. The duration of leave you request does not impact the application itself but will affect the amount you need to pay for the Immigration Health Surcharge.

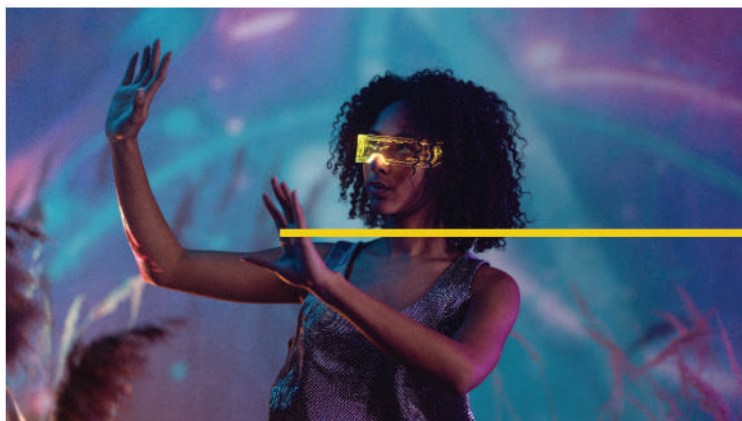

To be eligible for a Global Talent visa in the fields of Science, Engineering, Humanities, Social Science, and Medicine, you must meet the following criteria:

**Age Requirement:** You must be 18 years old or above.

**Endorsement Letter:** You need to obtain an endorsement letter from one of the following organizations:

- Royal Society (for natural and medical science applications)

- Royal Academy of Engineering (for engineering applications)

- British Academy (for humanities and social science applications)

- UK Research and Innovation (UKRI) (for science and research applications) alternatively, you can be awarded a prestigious prize listed in Appendix Global Talent: Prestigious Prizes.

**General Grounds for Refusal:** Your application must not fall under the general grounds for refusal set by UK

Visas and Immigration.

**TB Certificate:** If required, you must provide a valid tuberculosis (TB) certificate.

## Requirements for Endorsement and Evidence required for Endorsement by the Royal Society

The criteria you will need to meet for endorsement depend on whether you are applying on the basis of Fast Track or Full Peer Review.





## Requirements for Endorsement and Evidence required for Endorsement by the Royal Society

---

For Fast Track endorsement, you must meet at least one of the following criteria:

**1. Peer-reviewed research fellowship or award:** Hold or have held a peer-reviewed research fellowship or award listed by the relevant endorsing body within the past 5 years.

**2. Academic or research position:** Be appointed to an eligible academic or research position at an approved UK Higher Education Institution or research institute listed by the endorsing body.

**3. Hosted or employed in a UK research organization:** Be hosted or employed in a UK research organization listed by

UKRI and provide critical contributions to work supported by a substantial research grant or award from an endorsed funder.

If applying based on being hosted or employed in a UK research organization, you must demonstrate either:

- Directing or participating in a unique research or innovation project with a PhD qualification or equivalent research experience.
- Making critical contributions to research by providing technical or domain expertise, with a UK bachelor's degree or equivalent research experience.

## Peer Review Endorsement

---

For Full Peer Review, which is considered by The Royal Society, The Royal Academy of Engineering, or The British Academy, you must show exceptional talent or promise in the relevant field and be an active researcher within a university, research institute, or industry. You also need a PhD or equivalent research experience and be at an early stage or recognized as an exceptional talent.

To support your application, you will need to provide relevant documentation depending on the

specific criteria you are applying under, such as written confirmation of fellowships or awards, job description and guarantee for academic or research positions, or a declaration from the research organization for hosting or employment.

If applying under Full Peer Review, you will need to provide a CV, a letter of personal recommendation from a UK resident eminent person, and an additional letter from another senior member of a reputable UK organization in your field.

Applicants in the Global Talent category who are applying to enter or extend their stay do not need to meet an English language requirement. However, it is important for Global

Talent migrants to have an adequate level of English language proficiency in order to be eligible for settlement in the UK.

Applicants in the Global Talent category who are applying to enter or extend their stay do not need to meet an English language requirement. However, it is important for Global Talent migrants to have an adequate level of English language proficiency in order to be eligible for settlement in the UK.



## What is the duration of validity for a UK Global Talent Visa?



Global Talent visa applicants have the flexibility to choose the duration of leave they request, in whole years, up to a maximum of 5 years, in a single application. This allows applicants to tailor their visa duration according to their specific needs. By selecting a shorter duration, such as 2 years, applicants can minimize their payment for the Immigration Health Surcharge.

## Global Talent Visa Extension

If you wish to prolong your stay in the UK beyond your initial granted period or if you are unable to apply for settlement after your initial grant of leave, you have the option to extend your stay in the Global Talent visa category. There is no maximum limit on the number of years you can stay in the UK under this category.

To qualify for an extension, you must have earned income in the UK during your last grant of leave, and the earnings must be connected to the field for which you received your initial Global Talent endorsement (if you were endorsed) or related to the subject

matter of your prestigious prize (if you were granted the visa based on a listed prize). You need to provide evidence of these earnings from an independent and verifiable source, which will be reviewed by the Home Office.

If your initial application was endorsed, your endorsement must still be valid and not withdrawn by the endorsing body. The endorsing body must also maintain its approval status with the Home Office. Additionally, the Home Office will assess your character and immigration history to ensure that you do not fall under the general grounds for refusal.

# Global Talent ILR

If you meet the requirements for an extension of stay as mentioned earlier and demonstrate sufficient knowledge of the English language and life in the UK, you can apply for indefinite leave to remain (ILR).

After spending a continuous period of either 3 years or 5 years in the UK, depending on your specific circumstances:

**1.** If you were endorsed by the Royal Society, British Academy, Royal Academy of Engineering, or UKRI, or if you were endorsed under the exceptional talent criteria by Arts Council England or Tech Nation, or if you were granted your initial application using a prize listed in Appendix Global Talent: Prestigious Prizes, you will be eligible to apply for

ILR after a continuous period of 3 years in the UK.

**2.** However, if you were last endorsed under the "exceptional promise" criteria for Arts Council England or Tech Nation, you will need to spend a continuous period of 5 years in the UK before being eligible to apply for settlement (ILR).

The relevant continuous period can include time spent in the following immigration categories: Global Talent, Innovator, Tier 1 (excluding Tier 1 Graduate Entrepreneur), Skilled Worker, and T2 Minister of Religion, T2 Sportsperson, Scale-up, or Representative of an Overseas Business.





# Residential criteria for Indefinite Leave to Remain (ILR) as a Global Talent migrant

To be eligible for indefinite leave to remain (ILR) in the Global Talent category, you must not exceed 180 days outside the UK within any consecutive 12-month period during your continuous leave period.

If you are a Global Talent migrant endorsed by one of the endorsing

bodies for science, engineering, humanities, and medicine, and have conducted research directly linked to your granted leave outside the UK, those absences will not be considered when you apply for settlement. This exemption also applies to partners of Global Talent migrants.





## Transitioning to the Global Talent Route

If you are currently in the UK and wish to switch to the Global Talent route, you are eligible to apply as long as you do not currently hold or were not last granted permission to stay in the UK as a Visitor, Short-term Student, Parent of a Child Student, Seasonal Worker, Domestic worker in a private

household, or under any category outside the Immigration Rules.

However, if you hold leave in any of the above-mentioned categories, you will need to leave the UK and submit your application for a Global Talent visa from your home country.



# When Should I Apply for a Global Talent Visa?

To ensure a smooth application process, you should submit your Global Talent visa application within three months of receiving your endorsement. It's also possible to

apply up to three months before your intended travel date. It is advisable to plan your application timeline accordingly, working backward from your planned arrival in the UK.



## Duration for Global Talent Visa applications

When applying for a Global Talent visa, you can choose to use priority services at most application centers to expedite the processing of your application and receive a quicker decision. Generally, the processing time by the Home Office is estimated to be around one month. However, with priority services, it can take approximately one week to receive a decision. Some application

centers even offer a 24-hour processing service.

It's important to note that before your visa application can be processed, you must first await a decision on your endorsement application from the endorsing body. This waiting period for the endorsement decision should be factored into your overall timeline.

## Employment in the UK under a Global Talent Visa

As a Global Talent visa holder in the UK, you will have the full right to work, including self-employment and voluntary work. However, it's important to note that you cannot be employed as a professional sportsperson or coach.

There is no specific requirement regarding the amount of work you need to complete, but if you plan to settle in the UK permanently, it is expected that you engage in some form of work.

Additionally, you have the right to pursue studies in the UK if you wish to do so. However, it's important to remember that you are not eligible to access public funds during your stay in the UK.







## Is it possible for a Global Talent Visa holder to bring their family members?

Yes, Global Talent visa holders are eligible to bring their family members to the UK. This includes their spouse, civil partner, or unmarried partner. In addition, they can

also bring their children, as long as the children are under the age of 18 at the time of their first visa application to enter the Global Talent category
